SC Judgement: The Hon'ble Supreme Court of India has held in the case of Society for Unaided Private Schools of Rajasthan v/s U.O.I. & Others Writ Petition (C) No.95 of 2010 that the provisions of the Right of Children to Free and Compulsory Education Act, 2009 (RTE) shall not apply to Unaided Minority Educational Institutions. Government of India, New Delhi has declared St. John's High School, managed by the Congregation of Christian Brothers in India, to be a Minority Educational Institution within the meaning of Section 2(g) of the NCMEI Act. St. John's High School, Sector 26, Chandigarh, therefore, being a certified Christian Minority, Unaided Educational Institution, does not reserve 25% seats for the E.W.S. (Economically Weaker Section) as mandated in the Right of Children to Free and Compulsory Education, Act 2009. The school imparts education to the Christian community around and extends its service to the members of other communities to the extent possible.
- There are 5 printed pages in the form. Kindly ensure you have downloaded all the pages.

 Only those boys born between 1st April, 2019 and 31st March, 2020 will be eligible for KG admission for the academic year 2025-26. If your child is not within the age limit specified, he will <u>NOT</u> be considered for admission.

 There will be no screening of the children or their parents. Number of seats in UKG, in total = 160.
- Selection for free and open seats, if available after allocation of other seats, will be made by draw of lots on 18th January 2025 at the School premises at 10.00 a.m. Only a parent or an adult representative (ONE ONLY), CARRYING THE ACKNOWLEDGEMENT SLIP will be permitted to attend the draw of lots. Please do not bring children along.

No entry will be permitted for submission of forms after 11.00 am on 20th December 2024 under any circumstances. No self-attested form will be accepted.

 Incomplete forms/those filled with incorrect information/unattested forms or forms without all the required documents, will NOT be considered for admission. The list of eligible candidates will be displayed on 14th January, 2025. No. queries will be entertained if the name is rejected.


